Call to Order/Attendance

Approval of August 7, 2013 Minutes

- Mark expressed that the discussion about new board members should be discussed in closed session and recorded in separate minutes until such time as they agree to accept a position.
- Chip MOVED that the discussions pertaining to new board members be discussed and recorded in closed sessions. This is to be retroactive to the August minutes. Nancy SECONDED the motion. Motion passed unanimously.
- o The only correction noted in the August minutes was the spelling of Elise West's name. First name is spelled Elise rather than Alise.
- Nancy MOVED to accept the August 7, 2013 minutes with the above correction. Chip SECONDED the motion. Motion passed unanimously.

Old Business

- o Annual Appeal Letter Update Vicki
 - o Results as of Friday, August 30, 2013 Total received \$1,040
 - o \$960 in Memberships \$80 in Donations
 - o Membership includes eight renewals from long past expired members.
 - To date, not one response from a board member. Vicki expressed that it is important for the community to see that the Board Members are supporting their organization.
 - The Committee discussion the history of the appeals letter and decided to do another appeals letter leaving out the membership appeal in May.
 - o This will be included as a topic for the retreat next February.
- New Board Member Update Mark & Chip
 - Chip MOVED that the Committee meet in closed session to discuss the status of new board members. Mark SECONDED the motion. Motion passed unanimously.
 - The open meeting reconvened at 9:47 a.m. There are no actions to report.
- o Craft Fair Update Luci
 - o As of this date we have six vendors enrolled and a possibility of 3 more.
 - We need to check with Barbara Ellard as to whether she is planning on doing the food booth this year.
 - If Barbara is not available we will need to find another food vendor(s) possibly Café Soleil.

 The location of the food vendor is a prime location with access to the kitchen and we need to discuss possibly increasing the booth fee for that area.

New Business

- Signing of UAM Contracts Vicki
 - Chip signed the three contracts for the Division of Arts and Museums;
 \$5000 for the Local Arts Agency Grant; \$1000 for Onstage in Utah for the Thomas Pandolfi performance and \$1000 for Onstage In Utah for the Brad Richtor performance.
- Change Leader Institute Vicki
 - Discussed the possibility of sending someone to the Change Leader Institute in November. No one was interested in volunteering to attend.
- August Financial Report Luci
 - Luci passed out the August Financial report. She reported that the award from Arts and Museums came in at \$5000 rather than the \$4000 we had budgeted.
 - Luci will be reporting all the memberships received through the Appeals Letter in an "appeals" subcategory under Membership.
 - The \$500 co-sponsorship for Craig Childs has been submitted to Michael Plyler.
 - There was a discussion of how in-kind gifts are reported on the Financial Report. The Financial report can only reflect monetary donations. In-kind donations will be reflected on the Gift Giving Report that is managed by Vicki.
 - Mark suggested that any adjustments to the budget be submitted to the Board on a quarterly basis.
- Newsletter Update Luci
 - Luci briefly explained the layout for the September issue.
- Printing of Tickets for Gala Vicki
 - Vicki asked if the \$5 increase on the Gala tickets has been approved so that tickets can be printed. The price increase needs to go to the Board for approval.
 - Mark **MOVED** that the cost of the Gala tickets be increased from \$45 to \$50 for members and from \$50 to \$55 for non-members. Chip **SECONDED** the motion. Motion passed unanimously.
